An Act relating to the Creation of Government-Funded Pensions

Assented to on the 27th of February, 2023

SARHOLM, 2023

E IT ENACTED, by the Office of the Prime Minister of the New Sarovian Empire and Her Colonies and Dominions, with the advice and consent of the Imperial Parliament thereof, as follows:

The Two Pensions

1. His Imperial Majesty's Government has long since had the desire to establish a pension for the hardworking civil servants and military members of the New Sarovian Empire. Under the government of the Caps, the Ministry of Finance has established two pensions for members of the New Sarovian Empire to utilise: the civil pension and the Armed Forces pension (AFP).

These pensions shall place a hard cap on the salaries of civil servants and members of the armed forces in exchange for life-long Saro support for continuous service. These Saros, as per the Currency Act of 2020, can be directly exchanged for Gralats on GraalOnline Classic. Pensions shall be available to all who fit the eligibility requirements, regardless if they remain in the New Sarovian Empire actively or not; these pensions shall not be revoked or removed. A pension may only be legally removed from an individual if they are found guilty and convicted of a serious crime under the Mathiveas Code of Law.

The Purpose of the Civil Pension

2. The Civil Pension is given to all members of the Civil Service of the Imperial Government who serve for a period of six months or more continuously with no gaps. The pension shall encourage and incentivize citizens of the New Sarovian Empire to work for the Government in various civil positions, such as clerks, ambassadors or other.

Eligibility

3. In order to qualify for a Civil Service pension, you must meet all of the following criteria:

- 1) You must possess a named position listened in the Civil Services Act of 2023,
- 2) You must not currently possess an Imperial Armed Forces pension, or relinquish it,
- 3) You must prove a record of working for the Civil Service for this period of time if asked.

Pension Numbers

4. If you qualify for a Civil Service pension, you will receive a monthly pension of 1,200 Saros (paid 300Sr per week). If you can prove continuous Civil Service for a total of 8

months, or one full year (365 days), your pension will increase to 1,600 and then 2,200 respectively. Civil servants cannot collect AFPs and the Civil pension.

The Purpose of the Armed Forces Pension

5. The Armed Forces Pension (AFP) is given to all members of the Imperial Army, Navy or other branches decreed by the Crown who serve for a period of 14 months continuously with no gaps. This will include members of the National Service Registry and the Reserve Force, but only for members who routinely show up for duties befitting of a Reservist, such as monthly meetings, calls to arms, or other summons. The pension shall encourage members of the Armed Forces to serve in a variety of staff and field positions for long periods of time.

Eligibility

6. In order to qualify for the AFP, you must meet all of the following criteria:

- 1) You must be in the Imperial Army, Navy or other described branch with an official rank higher than the position of Recruit. Time spent as a Recruit shall not count towards your pensionable time.
- 2) You must *not* currently possess a Civil Service pension.
- 3) You must prove a record of service for the Imperial Army, navy or other described branch if asked.
- 4) If a Reservist, you must prove attendance at mandatory Army, Navy or other summons with a routine manner.

Pension Numbers

7. If you qualify for an AFP, you will receive a monthly pension of 800 Saros, paid in weekly instalments of 200. If you can prove continuous service for a total of 8 months, or one full year (365 days), your pension will increase to 1,200 and then 1,800 respectively. You may not collect the AFP and the Civil Pension at the same time - one must be forfeited.
