An Act Relating to Immigration Incentives

Assented to on the #th of Month, Year

E IT ENACTED, by the Office of the Prime Minister of the Dominion of

Carolusburg, with the advice and consent of the Royal Carodian Parliament thereof, as follows:

Immigration

1. Immigration to The Dominion of Carolusburg is positive, this Act will facilitate and provide a range of incentives for people across the Commonwealth to immigrate to the dominion.

Definitions

- 2. The following terminology are defined as follows:
 - a. "Immigrant" is any individual seeking residency in the Dominion of Carolusburg.
 - **b.** "Sponsor" is any individual who assists an immigrant in migrating to the Dominion of Carolusburg.
 - **c.** "Publicly Employed" encompasses any governmental position, such as militia, navy, public official, or any other role established by the government.

Incentive

- 3. The following incentives will be provided to immigrants and sponsors as follows:
 - **a.** 20,000 Cronas each for immigrants and sponsors upon approval of their citizenship.
 - **b.** 20,000 more Cronas each for immigrants and sponsors if the immigrant remains for a minimum of 2 weeks as publicly employed.
 - **c.** A first time bonus on state employment opportunities, each job will pay out double the Cronas for one time only.
 - i. For example, currently you earn 20,000 Cronas for 1000 gralats worth of minerals given to the government, this bonus for new settlers would allow them to earn 40,000 Cronas for their first exchange.

Sponsor Qualifications

- 4. A sponsor must meet the following requirements to qualify for incentives:
 - a. Is a Carodian citizen
 - **b.** Has no Carodian or Sarovian criminal record

Immigrant Qualifications

- 4. An immigrant must meet the following requirements to qualify for incentives:
 - a. Has no Carodian or Sarovian criminal record
 - **b.** Eligible for citizenship
 - c. Background check performed

Criminal Record Wavering

5. Criminal record requirements for immigrants and sponsors may be waived at the discretion of the Prime Minister, Governor General or any other minister thereby delegated.

Incentive Variability

6. All incentives are subject to variability plus or minus the amounts given in section 3. Alternatives may be offered in cases where there is no availability of funds. Alternatives are at the discretion of the Minister of Finance or any other minister thereby delegated.

Fraud

7. Individuals who commit fraud in order to receive incentives shall receive a minimum fine of 800,000 Cronas. It will be a criminal offence to commit fraud.
