**An Act relating to the Royal Carodian Militia Equipment Scheme**

*Assented to on the #th of August, 2024*

**BE IT ENACTED**, by the Office of the Prime Minister of the Dominion of Carolusburg, with the advice and consent of the Royal Carodian Parliament thereof, as follows:

#### Introduction

1. Whereas the Royal Carodian Militia currently requires its soldiers to independently purchase their equipment, and considering that the necessary equipment may represent a significant financial burden for some soldiers, it is acknowledged that these soldiers are in the service of His Majesty's Government. Recognizing that His Majesty's Government has previously guaranteed welfare provisions, it is thus acknowledged that His Majesty's Government should assume responsibility for purchasing equipment for those in its service who are unable to bear this cost.

#### Establishment of the Royal Carodian Militia Equipment Scheme

2. His Majesty's Government hereby establishes a scheme, to be managed and enforced by His Majesty's Ministry of the Treasury, or any body delegated by the Ministry, entitled the "Royal Carodian Militia Equipment Scheme" (henceforth referred to as RCMES, or the scheme). Under this scheme, the Government will provide the necessary Trade Currency to those soldiers who require it for the purchase of uniforms, VIP, repeaters, food, and .45s (for commanding officers only). Furthermore, His Majesty's Government will establish a "ticket bot" within its official Discord server to process applications for the scheme. These applications will be reviewed and processed by the Prime Minister, the Minister of Defence and Militia, the Minister of the Treasury, and a representative of the Crown.

#### Eligibility for the RCMES

3. To be eligible for the Royal Carodian Militia Equipment Scheme (RCMES), an individual must meet the following criteria: The applicant must be a citizen of the Dominion of Carolusburg and have been employed by the Royal Carodian Militia for a minimum of two weeks. Additionally, the applicant must have no criminal record within Carolusburg or the Empire at large. Furthermore, the applicant must be able to provide evidence to the Ministry of the Treasury demonstrating their inability to afford the necessary items within a reasonable timeframe.

Different items within the Royal Carodian Militia Equipment Scheme (RCMES) shall have specific criteria for eligibility. For any appropriate uniforms, an individual must have a minimum of two weeks of employment within the Royal Carodian Militia. Both combat and

ceremonial uniforms shall be available for receipt one time, unless this restriction is waived. For VIP access, an individual must have a minimum of two weeks of employment within the Royal Carodian Militia and hold a minimum rank classification as a Non-Commissioned Officer (NCO). VIP access shall be available for receipt one time, unless this restriction is waived. For repeaters, an individual must have a minimum of two weeks of employment within the Royal Carodian Militia. Repeaters shall be available for receipt one time, unless this restriction is waived. For food, there shall be no restrictions. For .45s, an individual must have a minimum of one month of employment within the Royal Carodian Militia and hold a minimum rank classification as a Commissioned Officer (CO). .45s shall be available for receipt one time, unless this restriction is waived.

#### Receipt of Funds Under the RCMES

4. To receive funds under the Royal Carodian Militia Equipment Scheme (RCMES), a militiaman must open a ticket via the designated bot and demonstrate their ability to meet the criteria listed above. They must specify the items they are requesting (e.g., "I request an officer's ceremonial uniform. I request a repeater.") and demonstrate that they meet the criteria for each requested item. Upon approval, they will receive the necessary funds for the items they require. They must then post a screenshot of their purchase of the approved items within two days.

#### Miscellaneous

5. All items approved under the Royal Carodian Militia Equipment Scheme (RCMES) shall be the official property of His Majesty's Government. Consequently, it is henceforth a crime to defraud His Majesty's Government via the RCMES. Appropriate courts are hereby empowered to prosecute fraudulent behavior as well as theft regarding the RCMES. This includes, but is not limited to:

- a) Spending allocated funds on items other than those approved by the Ministry of the Treasury;
- b) Transferring the funds to entities other than the Ministry of the Treasury or the vendor of the requested items;
- c) Resigning from the Royal Carodian Militia within one month of receiving funds for the requested items.
