**An Act relating to the Creation of the Carodian  
Equestrian Federation**

*Assented to on the #th of September, 2024*

**B**E IT ENACTED, by the Office of the Prime Minister of the Dominion of Carolusburg, with the advice and consent of the Royal Carodian Parliament thereof, as follows:

#### Introduction

1. In recognition of the rich history and longstanding tradition of equestrianism within the Dominion of Carolusburg, and with the desire to promote and further develop this noble sport, His Majesty's Government, in concert with the Ministry of Culture, does hereby establish a Charter for the creation of the **Carolusburg Equestrian Federation**.

Since the founding of the Dominion of Carolusburg, equestrianism has been a cornerstone of its cultural identity. As a symbol of unity, heritage, and sport, the equestrian arts have captured the hearts of generations, becoming one of the nation's most celebrated activities. From the early days of exploration and conquest to the peaceful realms of sporting events, the horse has played an irreplaceable role in the history and development of the Dominion.

In light of this proud heritage and with the intent to elevate the sport of equestrianism to new heights, the Ministry of Culture, under the auspices of His Majesty's Government, hereby mandates the formation of a governing body that will oversee, regulate, and promote all equestrian activities within the Dominion.

#### Name

2. The governing body shall be known as the **Carolusburg Equestrian Federation (CEF)**, hereinafter referred to as "the Federation."

#### Board of Directors

3. The Federation shall be governed by a Board of Directors, appointed by the Ministry of Culture and endorsed by His Majesty's Government. The Board shall consist of:

- a. A President, who will serve as the principal representative of the Federation.
- b. A Secretary-General, responsible for the daily operations of the Federation.
- c. Additional members appointed by the Companies present in the Federation.

#### Companies

4. The Companies present in the federation are private companies from the Dominion of Carolusburg that wish to enter this sporting sector, and can be created only for the Federation or for various other uses. Furthermore, Companies must follow a series of protocols pre-established by His Majesty's Government, which can be changed at any time:

- a. The Company must have an owner, and officially register it within the Dominion of Carolusburg;
- b. To register with the Federation, the Company must pay a fee of 100,000 Cr to the Federation with the aim of encouraging the creation of new events, championships, as well as the prizes themselves.
- c. The Company must not have more than 3 registered jockeys at the same time within a competition.
- d. The Company must present 1 person before the start of the season to serve on the Board of Directors representing the company (this position will be occupied immediately by the owner of the Company, but he may appoint another person as well).

#### Horse Registration

5. In order for jockeys to participate in Federation competitions, they must register their horses. What includes presenting:

- a. Name:
  - i. The name of the horse, making it necessary to use a name in High Sarovian.
- b. Breed (must include the amount to be paid):
  - i. The breed of the horse can vary depending on the province in which the jockey resides and also the price of the horse. The horses of jockeys residing in Auro-Carodian provinces should be considered Aurean breed, while those residing in Carodian provinces should be considered Carodian breed.
  - ii. Purebred Horse (PB): 500,000 Cronas.
    1. These horses belong to a specific breed, without crossing with other breeds. Like Pure Aurean.
  - iii. Halfbred Horse (HB): 200,000 Cronas.
    1. The half-blood horse results from the crossing between a purebred horse and a horse of another breed or without a defined breed.
- c. Appearance:
  - i. The appearance of the horse must be obviously a horse, unrealistic mounts will not be allowed in the Federation.

In addition to this series of regulations, horses live on average 4 AS, that is, if this date is reached the horse would be officially considered dead and the jockey would have to register a new horse.
