An Act Relating to Farming and Exchanges

Assented to on the 26th of August, 2024

SARHOLM, 2024

E IT ENACTED, by the Office of the Prime Minister of the New Sarovian Empire and Her Colonies and Dominions, with the advice and consent of the Imperial Parliament thereof, as follows:

Farming

1. The primary method of generating gralats within Estos is through farming, traditionally no formal legislation has been enacted to protect farmers and offer better compensation to individuals who generate gralats for the "Saro-Gralat" exchange. This bill seeks to do this.

The Saro-Gralat Exchange

2. The Saro-Gralat exchange allows all citizens to exchange their Saros for gralats, to purchase uniforms, hats, or anything they wish to purchase.

- **a.** The Saro-Gralat Exchange is to be organised by the Minister of Finance, and can be delegated to other individuals.
- **b.** The Minister of Finance is to set maximum exchange limits, based on the availability of gralats.
- **c.** Individuals can be barred from the exchange by the Prime Minister, for any reason.

The Imperial Union of Farmers

3. Henceforth, any and all farming for the government should be carried out by The Imperial Union of Farmers.

- **a.** The Imperial Union of Farmers is in charge of ensuring farmers and the government can work together effectively to achieve the best possible exchange.
- **b.** The Imperial Union of Farmers will protect and ensure the wellbeing of farmers.
- **c.** The Imperial Union ensures that all farmers communicate the amount of gralats within their farms.
- **d.** The Imperial Union should clearly communicate and set targets they want achieved.
- e. 7 days worth of rest should be given to farmers after an exchange
 - i. In extraordinary circumstances, this resting period can be cancelled.

Rewards & Payments

4. The government will guarantee certain bonuses for farmers.

- Farmers who exchange over 5,000 gralats are to be given 500 Saros in bonus payment.
- The % of pay for farmers is to be 75% of the gralats being exchanged.
 - $\circ~$ If 5000 gralats are exchanged, the farmer receives 3,750 Saros from the government.

Exchange Organisation

5. The Saro-Gralat Exchange has often been organised poorly. This act will aim to ensure a more coordinated process is in place so the exchanges are less impacted by disruptions.

- The Minister or individual appointed to organise the exchange, must begin calculating the gralats available for the exchange 48 hours from the exchange date.
- 24 or 48 hours from the exchange date, the individual in charge must begin announcing the exchange and taking orders.
 - All orders are to be kept track on through a spreadsheet provided by the Ministry of Finance.
 - Orders must state which farms will be used.
- The individual in charge must also ensure that the appropriate number of orders are taken, and limits are in place to ensure orders can be fulfilled.
