An Act relating to the Establishment of the Remerra Sarovi.

1. Short Title

This Act shall be known as the Boreas Act of 303 AS in short.

2. Introduction

The Imperial Parliament, recognizing that in an era of stagnation in the motherland of Estos and a surge in popular demands for expansion to the frontiers of the world in general and the continent of Boreas in particular, the potential of and need for a more permanent and developed presence on said continent has never been greater while affirming the validity of and our commitment to the values and principles of the Empire and Commonwealth wherever our people may be, as well as in our supreme fidelity and loyalty to His Imperial Majesty, Consteynnos IX, do declare the formal foundation of the *Remerra Sarovi*, otherwise simply known as the *Remerra*, an organized and civilized political entity encompassing the Borean continent that is devoted to improving the lives of all its people and advancing the simple and utterly ineffable fact of Sarovian supremacy in savage lands and beyond.

3. Political Structure of the Remerra

The Remerra shall be so named according to the High Sarovian language. Upon translating to English, this will translate to "possession", and upon Portuguese, shall be translated to "patrimônio". It shall be a direct Crown Colony, with direct rule from Sarholm under the provisions decreed by the Colonial Secretary. The Remerra shall be personally administered by the Chief of the Commonwealth Corps - also known as the Secretary of State for the Colonies or Colonial Secretary - or any representative of their or His Imperial Majesty the Emperor's choice. The Secretary will serve as the primary executive authority of the Remerra and may govern the Remerra how he/she and the Sarovian Government sees fit.

4. Legislative Council

The Remerra shall possess a Legislative Council which will meet in the Legislative Building in the City of Constantia and serve as an advisory and consultative body to assist in the Remerra's governance. The Council will be composed of two groups:

- a) All ennobled members of the Sarovian Assembly of Peers will be free to attend meetings of the Council. They shall cast one collective vote.
- b) The Colonial Secretary shall appoint at least three Sarovian citizens preferably members of the Civil Service to attend meetings of the Council. They shall serve as the primary body of the Council, with each Councilor casting their own vote.

If a bill is passed, the Secretary may choose to sign the bill into law, or to veto it. All procedures of the Council not enumerated above may also be decided by the Secretary, as well as who shall serve as the chair of each group and how the bill is enforced if signed.

5. Military Structure of the Remerra

The Remerra shall be garrisoned and defended by a well-regulated Militia, under the supervision, command, control and training of the Imperial Sarovian Navy but within peacetime, separate from it. The Colonial Secretary is responsible for choosing, on the advice and consent of the Admiralty, a Sarovian citizen to command this Militia. Members of the Militia may be members of the Imperial Sarovian Armed Forces, but no member of the Militia who is also a member of the Imperial Sarovian Armed Forces may participate in the Legislative Council or any other civil office in the Remerra. All members of the

Militia must be Sarovian citizens.

6. Appendices

The Remerra shall be open to all with the ability to access it. However, only Sarovian citizens are eligible to participate in the Militia and Legislative Council.

The currency of the Remerra shall be the Saro. The Remerra shall operate in full monetary union with the New Sarovian Empire itself.

The Colonial Secretary, as well as His Imperial Majesty the Emperor, may eject any individual from the Remerra, at any time, for any amount of time, for any reason.

The flag of the Remerra shall be the flag of the former Boreas Colony - a red Sarovian ensign displaying a polar bear, which shall serve as the national animal and symbol of the Remerra.
