An Act Demanding Stricter Enforcement by the Commonwealth of a Uniform Security Standard.

Given Sanction on the 25th of April, 2023 Struck and repealed on the 19th of February, 2024

1. Short Title

This Act shall be known as the Declaratory Act in short.

2. Introduction

The Imperial Parliament, acknowledging that the purpose of the Sarovian Commonwealth as stated by the Commonwealth Act 2022 is for the Commonwealth to be a "formal legal body facilitating diplomacy, peace, coordination, and co-equal enrichment", noting, however, that since the Commonwealth's founding, certain member states have aided and abetted traitors who were formerly members of the New Sarovian Empire and seeing a serious need to condemn the aforementioned actions as part of the Imperial Parliament's responsibility to ensure the safety of the Sarovian people and the stability of the greater Commonwealth, hereby condemns the continued presence of these traitors within the Commonwealth and declares the following provisions in accordance with this condemnation.

3. Terms of the Treaty

The Imperial Parliament hereby orders the Imperial Government, Constabulary, Armed Forces, and other associated/relevant entities to institute what shall be known as the Banishment Readiness Condition system, or BACON. This shall be a rating system grading the severity of people's banishment from the Empire, and shall consist of:

- a) BACON 1: Special Circumstances
- b) BACON 2: Banishment due to high treason
- c) BACON 3: Banishment due to unacceptable personal behavior
- d) BACON 4: Expulsion, with chance of return

Additionally, all persons currently banned from the Empire are to be categorised and listed in a single database of banned persons, to be maintained by the Imperial Constabulary, in cooperation with the Defence Staff. Removal from the list must be approved by a Judge of the First Court, or the Minister of Justice if none are available.

It is vital to condemn any inconsistencies in security within the Commonwealth. It is impermissible for members of the Commonwealth outside the Empire to aid and abet ex-Sarovian traitors.

4. Declaration to the Commonwealth

Therefore, the Ministry of Foreign and Colonial Affairs is ordered to communicate to the rest of the Commonwealth the aforesaid message to all other members of the Commonwealth, and to ensure through whatever means necessary that those people on the list of banned individuals who the Sarovian Government deems as security threats to the Commonwealth as a whole are either banned from where they currently are, extradited to the Empire for lawful trial, or both.

Additionally, the Ministry of Foreign and Colonial Affairs and the Defence Staff are ordered to, along with any other relevant entities, cooperate and coordinate in whatever ways necessary to ensure that noncompliance with these demands is dealt with swiftly.
