An Act to Defend, Create and Establish Legally Sarovian Families.

*Given Sanction on the 12th of February, 2025*

- 1. Short Title** This Act shall be known as the *Family Compact Act* in short.
- 2. Preamble** Wherein the entire Sarovian state is based on the familial system, with the patriarch of the family serving as the Rozirre, the family must also be adopted for the everyday citizens of Sarovia Rechae. The Family Compact Act legislates the different roles and structures of a family, including the requirements to keep a family alive, active and working. The Act also repatriates a series of legacy families whose ancestral homes have fallen outside of favour of Sarholm.
- 3. Familial Structure**

Each family must possess at least three roles. These roles can be translated into English or Portuguese as “patriarch”, “partner”, and “heir”, as the Sarovian system of family destroys all gender concepts for these three roles.

Every family shall be led by a *Pazietella*, or a Patriarch. The *Pazietella* is in charge of the family, manages the *Charata do Fami* and is the main individual and owner of the family. Should the *Pazietella* die in any way in accordance with the Life & Death Act, the ownership of the Family and the title of *Pazietella* goes to the *Hare*, or Heir.

The *Hare* is always the individual who will take the position of *Pazietella* and the ownership of the Family next. The *Hare* can be anyone in the family, as dictated by the *Pazietella*.

Lastly, the *Amorrene*, or Partner, is the wife, husband or marriage partner of the *Pazietella*. The *Amorrene* does not have to be of the opposite sex, nor does the *Amorrene* have to be a romantic partner. The *Amorrene* is equal to the *Pazietella*, but their role is to recruit new individuals to the Family, or marry members of the Family to other families. The *Amorrene* cannot be the *Hare*, and must be on equal footing with the *Pazietella*.

In many ways, the *Pazietella* is the owner of the Family, and ensures the Family laws and culture is preserved, and has final say. The *Amorrene* is responsible for the administration of the Family and its advancement within society and recruitment of new individuals. The *Hare* is the successor and heir to own the Family when the *Pazietella* dies.
- 4. Family Charters** All families have the right to write, publish and codify their own Family Charter, or *Charata do Fami*. This Charter may dictate the rules of succession within the family, who the family will be led by, serve as an unofficial will, dictate terms of marriage, familial oaths, dowry payments and more. In no circumstances may a Charter circumvent Sarovian or Imperial law. The *Charata do Fami* must be submitted to the Minister of Services and the Privy Council Clerk for safekeeping and must be published in the description of the Family. Both the *Pazietella* and the *Amorrene* must agree to edit the *Charata do Fami*.
- 5. Prevention of Inactive Families** All members of the Sarovian citizenry are eligible for recruitment into a Family provided the Family has acceptable room for the member. Sarovian citizens are, upon becoming a Sarovian citizen, immediately advertised to all Families for recruitment in a manner the government deems sufficient. Should no Family choose to incorporate them, the Government may automatically assign members into Families within one week.

Should a Pazietella or Amorrene be inactive within a Family, or die without an Hare, the Ministry of Culture, in possible cooperation with the Inheritance Committee of the Privy Council, may select a closest living relative to be the head of their family.

## **6. Repatriation of Sarovian Families**

Wherein certain ancient Sarovian families have been lost to time, or have had their ancestral homes lost, the Sarovian Government is repatriating all lost titles, claims, inheritances and names. The following families, who are not currently in Sarovian possession, will be repatriated by the Government:

- a) Fami eui Aeolos (Aeolus Family)
- b) Fami eui Feroxe (Ferox Family)
- c) Fami eui Walker (Walker Family)
- d) Fami eui Fairfax (Fairfax Family)
- e) Fami eui Atlas (Atlas Family)
- f) Fami eui Modena (Modena Family)
- g) Fami eui Magnus (Magnus Family)
- h) Fami eui Fauso (Faust Family)

Any family, current or no longer in Sarovian borders, can be patriated via an RDC.

## **7. Universal Family Charter**

All families have the right to create their own *Charata do Fami* in accordance with law. All families that do not create their own *Charata do Fami* are bound by the legal boundaries of the Universal Family Charter, seen attached.
