An Act Regarding the Locations of Meetings of the House of  
Commons and of the Assembly of Peers.

*Given Sanction on the 19th of June, 2024  
Struck and repealed on the 11th of September, 2024*

- 1. Short Title** This Act shall be known as the *Parliamentary Meetings Act* in short.
- 2. Preamble** The Imperial Parliament, acknowledging that neither the Charter of the Imperial Parliament nor the Constitution name an official meeting place for either chamber of Parliament and seeing a serious need to officialize this as well as to enact protocols for the potential use of other places given the recent terrorist attacks against Parliament hereby declares as follows:
  - a) The Speaker of the House of Commons may designate an alternate space to serve as the venue for a meeting should further security be required. The Prime Minister may also do so, with the consent of the Speaker. This space shall be known as a “Secure Commons Venue”, or SCV; or
  - b) Any SCV must be a House or Guild House under the control of a Sarovian citizen and must have enough seats for all 19 members of the House of Commons. It must also contain a public gallery area for other citizens to observe the meeting. The controller of the SCV must be online during the meeting.
- 3. House of Commons** The House of Commons shall host its meetings in the heretofore-used House of Commons building in the City of Sarholm. This enactment shall be accompanied by the following policies in case of extraordinary situations:
  - a) The Speaker of the House of Commons may designate an alternate space to serve as the venue for a meeting should further security be required. The Prime Minister may also do so, with the consent of the Speaker. This space shall be known as a “Secure Commons Venue”, or SCV; or
  - b) Any SCV must be a House or Guild House under the control of a Sarovian citizen and must have enough seats for all 19 members of the House of Commons. It must also contain a public gallery area for other citizens to observe the meeting. The controller of the SCV must be online during the meeting.
- 4. Assembly of Peers** The Assembly of Peers shall host its meetings in the heretofore-used Borhaus Palace, in the City of Sarholm. This enactment shall be accompanied by the following policies in case of extraordinary situations:
  - a) The Lord Speaker of the Assembly may designate an alternate space to serve as the venue for a meeting should further security be required. The Lord Privy Seal may also do so if the Lord Speaker is absent, but the Lord Speaker can overrule this if the meeting has not yet occurred. This space shall be known as a “Secure Peers Venue”, or SPV; or
  - b) Any SPV must be a House or Guild House under the control of a Peer or Knight, and must have at least 11 seats. The controller of the SPV must be online during the meeting.
