An Act Reforming and Reinforcing the Security Standards of the
New Sarovian Empire.

- 1. Short Title** This Act shall be known as the *State Security Act* in short.
- 2. Preamble** The Imperial Parliament, acknowledging that the Declaratory Act 2023 has done a good job with formalizing the security standards of Sarovia, however as noted that since the passing of this Act, treason has continued to be a problem due to a variety of factors. Seeing a serious need to institute corrective practices in order to destroy institutional rot and keep the working people of Sarovia safe and free in their own guild, hereby repeals the Declaratory Act 2023 in favor of this new Act, which updates and strengthens the procedures.

- 3. Banishment Readiness Conditions** It is clear that neither the Imperial Armed Forces nor the Imperial Constabulary are enforcing the Banishment Readiness Condition system, or BACON. It is necessary, therefore, to reiterate the nature of this system and expand on it. So, it will consist of:

- a) BACON 1: People with this classification are top-level security threats to Sarovia and the Sarovian Government should make all efforts to ensure they are not allowed in and that no Sarovians associate with them for their own safety. This level is also called the “Blacklist”.
- b) BACON 2: People with this classification have been banned from Sarovia by the Judicial System, but can be brought back through a Court ruling.
- c) BACON 3: People with this classification have been removed from the Imperial Armed Forces or the Civil Service due to inappropriate behavior, but have not been banned from Sarovia by the Judicial System.

The Imperial Parliament, in accordance with these changes, once again orders the Imperial Constabulary to maintain a list of banned people, or at the very least one of the BACON 1 and 2 levels.

- 4. Security of the Commonwealth** It remains vital to condemn any inconsistencies in security within the Commonwealth. History has shown that even when traitors return to the Commonwealth but not to Sarovia directly, they continue to commit evil acts.

Therefore, the Defense Staff is ordered to ensure that, in all Commonwealth Realms, such as but not limited to the Dominion of Carolusburg, this Act is implemented, both by passing similar legislation in those regions and by using the Imperial Armed Forces in strategic ways.
