An Act Relating to the Establishment of a Bilateral Trade Treaty with New Sarovia and the Dominion of Carolusburg.

Given Sanction on the 18th of December, 2024

- **I. Short Title** This Act shall be known as the *Treaty of Escora* in short.
- 2. Preamble

 In order to honour and respect the agreement known as the Leda Declaration, agreed to within the Charter of the Imperial Sarovian Federation, the New Sarovian Empire and Her Colonies and Possessions agree and consent to talks with the daughter nation of Carolusburg and Aurea in order to discuss trade, protection and sovereignty.
- 3. Signatories The parties of this agreement shall be His Royal Majesty the King in right of Carolusburg, as represented by the government of the Dominion of Carodia-Aurea and His Imperial and Most Stefanic Majesty the King and Emperor in right of the New Sarovian Empire and Her Other Realms, represented by the government of New Sarovia. These two entities shall be referenced henceforth by their names or through the term "nation(s)".
- 4. Repealment of the Carolusburg Trade Act of 311 AS shall, in accordance with the ratification of this treaty, be officially repealed by both parties. The Act has grown obsolete and causes both sides to suffer financially from the inflation of currency exchanges. Property will no longer be purchasable in Carodia by Sarovians without Carodian citizenship.
- The Saro-Crona currency exchange will be reestablished on a case-by-case basis, with the Carodian Government and the Sarovian Government working together to permit currency exchanges based on custom and tradition. The currency will remain a 1:100 exchange rate.
- 6. Commerce and The Carodian Government relinquishes control and sovereignty over the Carodian Discord Shop to the Sarovian Government, which is allowed to remove, add, contribute or change any contribution to the Carodian Discord Shop. The Sarovian Government permits the Carodian Government to add items to the shop with permission from Sarholm. The Sarovian Government is authorised and permitted to construct and develop resources in Carolusburg in accordance with the Leda Declaration.

The Carodian Government and the Sarovian Government agree to a tariff free trade deal, with the Carodian Government supplying New Sarovia with up to 450 fish, meat or grain by January 1st, which must result in the Carodian government developing their provinces to produce output. The Sarovian Government will supply 25 gems to the Carodian Government. Further trades will not require legislation, but a respective Rozirre/Royo-da-Conseili informing of future trades.

- 7. Expatriation of the Carodian Government acknowledges its place within the wider New Sarovian Empire, and hands over possession and amendment rights of the Carodian Constitution back to Sarholm, to be legislated, amended and adopted by votes of the Imperial Parliament in accordance with the Colonies and Dominions Act.
- 9. Enforcement This agreement shall enter the force of law twenty-four hours after both states have

ratified the agreement in accordance with their own laws and diplomatic procedures. This agreement shall be struck null and void for both states if either repeals its ratification in accordance with each state's own laws and diplomatic procedures. This agreement may be amended after its ratification if all states under the agreement also ratify the amendments in accordance with each state's laws and diplomatic procedures.
