An Act Relating to the Establishment of a Commission and
Institution Dedicated to the Establishment of Memorials,
Monuments and War Graves.

- 1. Short Title** This Act shall be known as the *Graves and Monuments Commission Act* in short.
- 2. Preamble** In order to honour and respect all servicemen that have served the New Sarovian Empire over all of its many years, an organisation to be known as the Imperial Memorial and Cemetery Commission shall be established.
- 3. Purpose** The purpose of the Imperial Memorial and Cemetery Commission shall be to establish public areas within Sarholm and other locations as determined, purchased and placed under the control of the Imperial Memorial and Cemetery Commission's purview. These public areas shall be designed, constructed and erected by artists commissioned by the Imperial Memorial and Cemetery Commission for the purpose of maintaining the legacy of Sarovia's war dead.
- 4. Organisation of the IMCC** The Imperial Memorial and Cemetery Commission will be established as an intergovernmental organisation, which will be jointly led by the Minister of Culture and the Minister of Defence. This organisation will select no more than three additional members whom they believe are important additions to the Commission, to be known as Memorial Commissioners. They shall not receive any additional perks or privileges or pay.
- 5. Funding** The Imperial Memorial and Cemetery Commission will be funded by the Imperial Parliament no less than 3,500Sr per month in order to fund new memorials, gravesites and similar topics. Dominion Governments may be requested to match this pay by the Imperial Parliament.
- 6. Establishments** The Imperial Memorial and Cemetery Commission shall, on direction from the Government and its Commissioners, begin to oversee a new "memorial park" that will be named by the Commission with approval from the Sovereign, who will serve as the patron of the Commission. This Commission shall establish four categories of memorial establishments, which shall be:
 - a) *War Memorials*; which shall commemorate specific engagements and conflicts often inscribed with the names of fallen members who fought in those wars
 - b) *Cemeteries*; which shall consist of individual graves of all qualified servicemen of the Imperial Army and Navy who have been declared to be in a state of *morte*,
 - c) *Cenotaphs*; which shall honour servicemembers which cannot be identified; and
 - d) *Monuments*, which shall serve as a "catch-all" for specific deeds, conflicts or wars.
