An Act relating to the Declaration of a State of Conflict between
the *Perdizos* and the New Sarovian Empire and Her Colonies and
Possessions.

Given Sanction on the 27th of March, 2025

1. **Short Title** This Act may be known as the *Imperial Declaration Against the Perdizos Act of 327 AS*.
2. **Introduction** The New Sarovian Empire, alongside the Dominion of Philippia, and the Dominion of Carolusburg and Aurea, in continuance with the terms agreed upon by the powers who signed the *Treaty of Tristopoli* and being assembled in the fight for peace, order, good government and democracy and, remaining comprehensively informed of the misappropriation, thievery and perpetual crimes against order and justice, do see it necessary to make a solemn declaration of the sentiments of the Imperial Parliament.
3. **The *perdizos*** The aforementioned powers, who are aware that Jacob Riesburg and his small band of persistent yet inactive *perdizos* remain a nuisance to peace and stability, owe it to the dignity of society to defend Estos against the anti-democratic, anti-truth, anti-law, anti-creative, and anti-monarchical terroristic ideology that is spoon-fed to Jacob's *perdizos*. These *perdizos*, men and women of fealty a cause so lost it neither exhibits nor possesses any strains of common sense or legality, remain swept up in heavy propaganda which could delude even the most intelligent of citizenry, and must be crushed.
4. **Reasons for this Declaration** Time and time again, the New Sarovian Empire has exercised its right as *lauterra's* sole hegemon and authority on peace and stability to provide opportunities for Jacob Riesburg and his *perdizos*, despite their many transgressions, insults and attacks against the Sarovian people - to live in peace. In 2020 and 2021, the *perdizo* and *iacobizo* cause was defeated swiftly, and great properties, prestige and titles were given back to those *perdizo* who had rebelled against Sarovian authority, in the name of moving on. Nevertheless, they rebelled again, and in 2022, the *perdizo* were fully vanquished and permanently defeated, until previous statesmen under the Marchwood Administration permitted the return of some lost souls, reigniting the spark of the *perdizo*. Nonetheless, the New Sarovian Empire permitted many *perdizo*, including Jacob Reisburg, to retain influential positions outside of Sarovia such as the Papacy, and supported the *perdizo* peoples in many ways in order to find perpetual peace. Nonetheless, their attacks against the Sarovian people continued, and in 2023 and 2024, the *perdizo* were defeated twice, with a peace agreement being signed to end this conflict forever, which remained unfollowed and neglected. Open hostilities did not begin until the false and illegitimate claims on Sarovia's monarchy, not to mention the incessant inability of the *perdizo* to create anything unique or meaningful and the constant misappropriation of Sarovian culture, ideas and worldbuilding. The *Treaty of Tristopoli*, uniting all powers against the *perdizo*, finalised peace between Hanoria and New Sarovia and united said powers against the aforementioned rot.
5. **Failure to Uphold this Convention** Due to some parties to the *Treaty of Tristopoli* being influenced by sedition and lost, the House of Wallon has joined the ranks of the *perdizos*, welcomed by the arms of Jacob. This unfortunate incident did not spark any retaliation, as New Sarovia had restrained herself for months out of the fear of being an aggressor and needlessly antagonising the affairs of Estos. However, through Jacob's continuance to unlawfully and illegitimately claim that they are Sarovian, Jacob shatters the only restriction placed upon New Sarovia on which his very existence and longevity depends, and by appearing again to claim the Sarovian throne with his incessant projects of confusion, disorder, misappropriation, schizophrenia

and delusions of grandeur, he has deprived himself of the protection of he and his peoples for perpetuity, and has clearly demonstrated that there can be neither peace, agreement or truce with him, with any party and by any party.

6. Declaration

The aforementioned powers concretely declare that Jacob Riesburg and his *perdizos* have placed themselves in a situation that is entirely of their own doing, and by disturbing the tranquility, peace and stability of the state, he has rendered himself liable to whatever may befall him and his *perdizos*, as it was rendered to them in years previous and will be rendered again.

The powers do declare that they firmly resolve to maintain the *Imperial Family* policy, and all dispositions sanctioned by that Imperial Ordinance, and that all parties to this Declaration, from the moment of Imperial Sanction onwards, hereafter resolve to employ all their means and unite all efforts so that the general peace may be maintained and restored and that the lost return to the light or to the ground, permanently and forever, so that Jacob Riesburg and his *perdizos* can no longer threaten to plunge the community into the disorders, misfortune, miseries and chaos of tyranny, anti-democratic principles and misappropriation and thievery.

And although the powers are entirely persuaded that all of Hanoria is neither in league nor condones the actions of Jacob and the *perdizo*, the powers acknowledge no legitimate sovereign on Hanoria's throne due to no legitimate heir in accordance with the *Treaty of Tristopoli* and thusly do declare that if no rightful sovereign is anointed by the Holy Stefanic Church in leagues with the aforementioned treaty and agreement, it is up to all patriotic Hanorians to rally around the heir presumptive in accordance with the rule of law and Hanorian succession, Carolus XIII, and should this legitimate Hanorian sovereign be attacked or threatened, as soon as Hanor shall call upon Sarovian arms to defend the *Imperial Family* policy, the Sarovian people will, by force of arms, be ready to give to a rightful Hanorian sovereign and the Hanorian people a truly independent, creative, active and legitimate Hanorian nation.

7. Declaration of Hostilities

With all above confirmed by the aforementioned powers, and in succession with the Sarovian victory at Cuive nearly a Stefanic year ago, it is blatantly clear that there is no hope for a peaceful state of existence between the *perdizo* and the Sarovian people, and as such, to protect truth, law and order, it has been deemed necessary for us to embrace a sentiment of open war. Such a declaration has been decided upon by the Cabinet and the Prime Minister, under advice from His Imperial Majesty's Imperial Defence Staff, and in accordance with the Prime Minister of Philippia and the Prime Minister of Carolusburg and Aurea.

8. Terms of Hostilities

Upon Imperial Sanction of this law, all Sarovian military and civilian assets are to be employed as necessary in hostile activity against the *perdizo*, until the unconditional surrender of Jacob Riesburg, the absolute dissolution of the *perdizo* ideology, or both.

To this effect, the following will apply upon Imperial Sanction and exist for the duration of the conflict:

- a) All agreements between the House of Zor-Mako-Vasa-Noesa and the House of Wallon are rendered null and void with the exception of the Surrender of Hanoria

in March 2025, and the *Treaty of Tristopoli*, between Hanor and Sarovia, shall be ruthlessly enforced;

- b) The Minister of Defence shall be appointed, with the Sanction of the Sovereign, as the *Merechelusa*, or Marshal of Marshals, with full powers and authority;
- c) The *Defence of the Realm Act* shall be lengthened to the length of the conflict; and
- d) The Hanorian people are given one week from the date of Imperial Sanction to renounce the *perdizo* and Jacob, as well as appoint a new Sovereign in line with the *Treaty of Tristopoli*, or by his Stefan-given right, the title shall fall to Carolus XIII.
