An Act relating to the Declaration of Emergency Powers in the Prime Minister to preserve the Sarovian State.

Given Sanction on the 16th of April, 2025



## SARHOLM



1. Short Title	This Act may be known as the <i>Preservation Act of 328 AS</i> .
2. Introduction	Whereas the Sarovian nation finds itself imperiled by terrorism, violence, foreign agitation and attacks; and whereas it is the sacred duty of the Crown and the People to preserve the unity, dignity, and strength of the Empire; and whereas the recent martyrdom of the Honourable Iosefe Atlas has revealed the urgent necessity of renewed vigilance and extraordinary measures; it is therefore necessary to work against all difficulties and hardships to preserve the Sarovian state.
3. State of national preservation	A state of National Preservation is hereby declared, as of 11:59pm EST on the 16th of April 2025, across all territories and provinces of the Empire. This declaration shall remain in effect until this Act of Parliament is formally appealed through legal means. The Defence of the Realm Act is officially repealed by the passage of this Act.
4. Emergency Powers	<ul> <li>The Prime Minister of the New Sarovian Empire, acting on behalf of His Imperial Majesty the Emperor, is hereby vested with extraordinary powers for the duration of the force of this Act. The Prime Minister may:</li> <li>a) Issue <i>Rozirre-da-Conseilos</i> on any topic with no restraint by statute or custom, granted it is not contrary to the Sarovian Constitution;</li> <li>b) Restrict, dissolve or destroy any seditious publications, gatherings, assemblies or efforts to dispel and damage the Sarovian state;</li> <li>c) Requisition property and assets for the purposes of national defence or development;</li> <li>d) Appoint special deputies of the Crown for any purpose with extraordinary powers detailed in Letters Patent; and</li> <li>e) Unilaterally create and establish any agency or institution, given that it is confirmed by statute by the repeal of this legislation.</li> </ul>
5. Legal immunity	The Prime Minister is provided full immunity as per the Sarovian Constitution, as all acts done are in the name of the Sovereign, and cannot be tried after the repeal of this legislation
6.Prorogation	The House of Commons of the Imperial Parliament is officially prorogued as of the 11:00PM EST, and shall return to session on command of His Imperial Majesty the Emperor.
