## An Act for His Imperial Majesty to Spend Money on the Affairs of State.

#### Rissiunno

This Act is tasked with the authorisation of allocating and dividing funds collected by the Imperial Parliament on behalf of His Imperial Majesty. In relation to the Primary Estimates and the Budget Visuals, this Act determines which ministries are allocated what finances and authorises them under the Great Seal to make appropriations requests.

1. Short Title

This Act may be known as the Sarovian Appropriations Act of 330 AS.

2. Introduction

With the introduction of the new SaroBot and through prudent and successful financial prowess, His Imperial Majesty's Government has, over a Stefanic decade, entirely reshaped the Sarovian economy, tackled the worst inflation in Sarovian history inherited by the Marchwood administration, and put more money into the pockets of Sarovians. This Budget is aimed to complete the final steps of the Prime Minister's comprehensive financial package - cut out the fat and eliminate the grifters who exploit the old Sarovian economy to enrich themselves, despite doing nothing to benefit the country. It is through this backdrop that significant government spending is necessary to fix the inactivity and sloth of the provincial governments through massive funding initiatives. With the government's large surplus, we can afford to splurge on making Sarovia's economy the strongest online economy found anywhere.

3. Expenses by Ministry Parliament allocates the following funds, collected by the provisions laid out in the Collections Act and the Taxation Act, to the following Ministries:

Colonial Affairs --- --- 75,000Sr
Culture, Tradition & Sport --- --- 430,000Sr
Defence --- --- 1,255,000Sr
Development --- --- 72,500Sr
Education --- --- 165,000Sr
Finance --- --- 593,500Sr
Foreign Affairs --- --- 30,000Sr
Immigration --- --- 60,000Sr
Justice --- --- 67,500Sr
Provinces --- --- 150,000Sr
Services --- --- 175,000Sr
Treasury Board --- --- 850,000Sr

It shall be the discretion of the respective Ministers, with authorisation and approval from the President of the Treasury Board, to dispense these funds according to the initiatives that develop by law and by decisions in Council.

Sovereign Wealth Fund

As a contribution under the Treasury Board, 500,000Sr will be allocated by law to the Sovereign Wealth Fund, which was established in 2024. This shall increase by a rate of 5% per week, with the hope that this money will increase over this budgetary period.
